# Doctor's pay

In talking with doctors and constituents about how to support family doctors in our community, one thing has been clear: the current fee-for-service payment model hasn't been working for everyone, and needed to be updated to address the needs of patients in B.C. That's why our government has been working hard and consulting with Doctors of BC to come up with a new model that will help doctors better support the health needs of British Columbians.



This new opt-in model will take effect in February, and instead of being paid only based on the number of patients seen each day, the new system will also take into account a number of factors:

- the time a doctor spends with a patient
- the number of patients a doctor sees in a day
- the number of patients a doctor supports through their office
- the complexity of the issues a patient is facing
- and administrative costs currently paid directly by family doctors.

This will raise the average wage for a family doctor in B.C., and ensure doctors can give patients the care and time they deserve. This model will help retain existing family doctors, and make family practice a more appealing option to new doctors who are starting their careers. # Health report overdose - toxic drugs

The toxic drug crisis has impacted families across North America, and BC has been at the forefront of the struggle to save lives and build a continuum of care that meets people where they are at. There is so much more to do; and bringing together an all-party committee brought all sides of the legislature together to further address this unprecedented crisis. I was privileged to be a member of this committee as we spent the last 6 months hearing from Health leaders, law enforcement, mental health and substance use experts, other jurisdictions, researchers, organizations, people who are on the ground every day working to keep people alive, and people who use drugs.

The recommendations follow through from over 100 presentations and nearly 900 submissions and it is our hope that they can build on the work the province has done already. The name of the report says it well – Closing Gaps, Reducing Barriers: Expanding the Response to the Toxic Drug and Overdose Crisis. The toxic drug crisis is not and should not be a partisan issue. We are all in this together, as people from all walks of life and in every corner of the province are impacted by a dynamic, ever-changing landscape that is called the illicit toxic drug supply.

# Progress on taking better care of our old growth forests:

Logging of old growth has declined by 42%, from an estimated 65,500 hectares in 2015 to 38,300 hectares in 2021. The area logged in 2021 represents 0.3% of the estimated 11.1 million hectares of old growth in the province. These old growth logging numbers are the lowest on record.

The essential benefits that old growth forest provides, such as clean air, clean water, carbon storage, wildlife habitat, recreation and conservation of biodiversity, are important to BC and future British Columbians. We are engaging in a new approach, one that works in partnership with First Nations and has full engagement of local governments, stakeholders and the public.
