1) Living wage

We are adding additional supports to assist people and businesses offset their energy bills heading into the colder months - and providing lower income families with a new BC Affordability Credit in January. These measures build on the cost-of-living supports announced in September a package that is putting close to \$2 billion towards helping lower income B.C. families get by during this difficult time.

We know that everyone deserves to feel safe in their community and we also all agree that what's happening right now isn't working for people. Just two days after being sworn in Premier David Eby has announced our Safer Communities Action Plan. There's been a rise in repeat violent offending across Canada from unintended consequences to the federal government changes to the Criminal Code. Add in increased mental health and addiction challenges brought on by the pandemic and the toxic drug crisis, and it is seen across North America. What's in the Plan?..... *Stronger enforcement and intervention services

*New repeat violent offender response teams.

*Consequences for people who continue to commit violent crimes and strengthening intervention services to prevent crime in the first place –

*Working with Ottawa to make the changes to federal laws that all the provinces need.
